Privacy Notice (How we use child information)

The categories of child information that we process include:

- personal identifiers and contacts (such as name, unique pupil number, contact details and address).
- characteristics (such as ethnicity, language, and free school meal eligibility).
- safeguarding information (such as court orders and professional involvement).
- special educational needs (including the needs and ranking).
- medical and administration (such as doctors' information, child health, dental health, allergies, medication and dietary requirements).
- attendance (such as sessions attended, number of absences, absence reasons and any previous settings attended).
- behavioural information (such as exclusions and any relevant alternative provision put in place).

Why do we collect data about you?

We process personal information to enable us to provide childcare, encourage and supervise educational play, to advertise our services, to maintain our own accounts and records and to support and manage our staff.

Type/classes of information processed

We process information relevant to the above reasons/purposes.

This may include:

- personal details
- family details
- GP contact details
- lifestyle and social circumstances
- digital images of the child's progress
- financial details
- education and employment details
- goods or services provided

We also process sensitive classes of information that may include:

- physical or mental health details
- racial or ethnic origin
- religious or other beliefs
- trade union membership

Collecting child information

We collect child information via registration forms & parental agreement forms at the start of each term.

Child data is essential for the settings operational use. Whilst most of the child information you provide to us is mandatory, some of it is requested on a voluntary basis. To comply with the data

Storing child data

We hold child data securely for the relevant amount of time.

Who we share child information with

We routinely share child information with:

- schools that the pupils attend after leaving us.
- our local authority.
- the Department for Education (DfE).

Why we regularly share child information

We do not share information about our children with anyone without consent unless the law and our policies allow us to do so.

Department for Education (DfE)

The Department for Education (DfE) collects personal data from early years settings and local authorities via various statutory data collections. We are required to share information about our children with the Department for Education (DfE) via our local authority for the purpose of those data collections.

All data is transferred securely and held by the Department for Education (DfE) under a combination of software and hardware controls, which meet the current government security policy framework.

Requesting access to your personal data
